### I Context

To further improve the friendship between West Ukrainian National University and Shaoxing University and to enhance the popularity of the Chinese calligraphy and culture worldwide, Shaoxing University agrees to work with West Ukrainian National University by establishing "Lanting Calligraphy Academy" in West Ukrainian National University, which shall be a platform aimed to provide calligraphy learning and teaching courses for students and teachers from both parties.

### II Program in Cooperation

Party A and Party B shall be in cooperation to establish "Lanting Calligraphy Academy" in Party B.

### III Scheme for Cooperation

1. Party A and Party B shall enter and put into practice the friendship and cooperation. The "Lanting Calligraphy Academy" shall be established by Party A in Party B. The cost of facilities, calligraphy teachers, accommodation and transport should be specified under the negotiation between two parties.

2. Teachers and students from Party B can have access to any further calligraphy programs and other academic, cultural communication and collaboration activities.

3. Aside from lectures, communication between both parties shall be strengthened through the Internet and MOOCs to seek closer relationship and interactions between teachers and students.

### IV Teaching Scheme

"Lanting Calligraphy Academy" shall be in operation by offering both online programs and offline lectures.

1. It shall be the Party A's responsibility to offer offline calligraphy classes, and shall provide for Party B the qualified teachers and students. The specific number

and duration of stay of the Chinese teachers and students is subject to negotiation between both parties for any adjustment when necessary.

2. Online programs shall be offered on the network-based platform and MOOCs for the purpose of sustainable collaboration.

### V Rights and Obligations

1. Rights for Party A

Party A has the rights to popularize the traditional Chinese art by offering classes in "Lanting Calligraphy Academy" in Party B.

2. Rights for Party B

Party B has the rights to enrich the school life for students in "Lanting Calligraphy Academy".

3. Obligations for Party A

Party A shall be obliged to take responsibility of providing desirable resource for calligraphy teaching to ensure the normal operation and management of "Lanting Calligraphy Academy" in Party B.

4. Obligations for Party B

Party B should help Party A to establish "Lanting Calligraphy Academy" in Party B.

Party B shall be obliged to provide assistance to Party A concerning the operation and management of "Lanting Calligraphy Academy" in West Ukrainian National University, and any procedure necessary for the teachers and students' arrival to and departure from West Ukrainian National University.

This letter of intent shall be written in duplicate and each party shall keep one Ukrainian copy. The letter will take effect upon the signature of both parties.
