Participation in the conference: in-person, remote.



4. ABSTRACT FORMATTING RULES

- 1. Only scientific papers that have not been published before are eligible for submission.
- 2. Length: 2-3 FULL pages, including figures, tables and references.
- Abstracts should be prepared in the MS Word editor. A4 page size.Margins - 2 cm on all sides. Pages are not numbered.
- 4. Structure of the abstract (font Times New Roman, size 14 pt, 1.5 spacing):
- > UDC index (in the upper left corner of the page);
- Surname, initials of the author (in the upper right corner of the page, **in bold**);

> academic degree, academic title, position, affiliation (name of institution, department) of the author (non-Ukrainian authors should also indicate the name of the country) - right alignment;

title of the abstract (report) - capital letters, centre alignment, **bold**;

→ the list of used sources is placed after the text of the abstract under the heading References (bibliographic description of literary sources is compiled in accordance with the National Standard of Ukraine DSTU 8302:2015 'Information and Documentation. Bibliographic reference. General Provisions and Rules for Compilation'); in-text citations should be given in square brackets, for example [3, p. 68; 5, p. 37].

> use Times New Roman font, 12 pt, **bold** for table titles and figure captions. All figures should be grouped as a single object. Centre alignment is required for formulas.

> use of scanned graphic objects is prohibited.
