**Abstract Submission Guidelines**

Abstracts should be no longer than three pages and must be submitted in Microsoft Word format. The preferred font for the title and text is Times New Roman, 14 pt font size, between line spacing should be set at 1,5. Your abstract should not include numeration of pages.

**The Manuscript should be structured as follows:**

- UDC index (upper left-hand margin of the page).
- Author's name should be typed in bold lower case letters (without shortenings). No more than two co-authors are allowed.
- All author details (academic degree, institution/university, position, city, country) must be in single-column format and aligned flush with the right-hand margin of the page.
- The title of your abstract should be typed in bold capital letters in the centre.
- Manuscript: abstracts must be A4 size paper (210 x 297 mm) with 2 cm margins on all sides. Do not use hyphens in the text, fractional numbers should be represented through a comma (e.g., 0.564). The preferred font for the headings of figures, graphs, tables is Times New Roman, 12 pt font size. Make sure you use the "Symbol Font" for all your symbols or embed your equation/formula within the text, using an equation editor. All figures should be grouped as a single object.
- References must be numbered consecutively in the order, in which they are mentioned in the text. Number the reference items and pages in square brackets (e.g. [1, p. 44]). References should be given at the end of the abstract with bibliography lists of sources in the original language.
