2. The goal and objectives of the course "Global Economy"

2.1. The goal of the course

The course "Global Economy" is aimed at forming in students a system of knowledge about the most important theoretical and practical aspects of the conditions and factors of formation, mechanisms and tools of the functioning of the global economy, assimilation of knowledge about the theoretical provisions and practical foundations of the development of the global economic system, potential opportunities for the development of national economies in the conditions globalization, as well as to determine effective strategies for realizing these opportunities.

2.2. The tasks of the course are:

- to provide students with an understanding of the essence of the main theoretical and methodological foundations of globalization, the factors of the formation of the global economy and the peculiarities of modern economic globalism, the asymmetry of global economic development;
- to teach students the correct use of methodological tools for substantiating economic phenomena that occur in the world economy;
- to develop students' practical skills in analyzing the trends of globalization of economic development, identifying and evaluating problems of international business development in the conditions of globalization;
- to form students' ability to develop strategic measures to ensure the international competitiveness of goods, services, international enterprises, industries, and inter-industry complexes.

2.3. As a result of studying the discipline "Global Economy", the student must know:

- prerequisites, factors, imperatives, regularities and modern trends in the formation of the global economy; processes of global corporatization of business; forms and models of regional economic integration;
- regularities of institutionalization of economic development; global priorities of scientific-technological, innovative-intellectual and civilizational development;
- factors and mechanisms of formation of global corporate leadership; monitoring of global economic cycles; cross-cultural corporate interaction, interactive interpersonal communication, personal social responsibility; planning, development and implementation of effective solutions for the production of high-quality products;

be able to:

- to analyze and forecast the nature and depth of subject interaction in the global economy;
- to analyze the sector-industry and regional-country structure of the global economy; modern functioning mechanisms of commodity, financial, service and labor markets; directions of global modification of market competitive mechanisms.

3. PROGRAM OF THE COURSE "GLOBAL ECONOMY" Content module 1.

Theoretical and conceptual foundations of the global economy

Topic 1. Economic nature of global transformations

Characterization of the basic concepts of the time space of globalization. The concept of "archaic globalization", its argumentation and characteristics. The main forms of manifestation of globalization.

The essence of globalism and the prerequisites for its emergence. Specific methods of global studies. Paradigms of modern globalism. The main forms of globalism and their content.

Subject and object of science "Global economy". The genesis of the concept of "globalization". Concepts of globalization and their evolution. Global economy, its definition and structure. Criteria for the level of globalization of national economies.

Global transformations and their theoretical reflection. Partial and systemic nature of global transformations. Factors of global transformations: scientific and technological progress and post-industrialism, expansion of the scope of activities of international organizations, liberalization of international economic ties, transnationalization, regional integration. National and regional strategies of economic transformations in global development coordinates.

Topic 2. Formation of the global economy.

Factors in the formation of the global economy. Signs of a global economy: incredible mobility of financial capital, global communications network, growing international division of labor.

The nature and features of modern economic globalism. Formation of the world scientific and information space, global information infrastructure. The social component of the global economy. Emergence of new global economic subjects.

Subjects of the global economy (individual subjects, influential personalities, world cities, corporations, clusters, states, regional blocs, international organizations). Natural and energy, innovative and technological, demographic and human resources of the global economy. Global information networks as a resource for the development of the global economy. Sectoral structure of the global economy and its diversification.

Global regional-local stratification. Formation of a global model of the international division of labor. Location of individual regions on the global world map (North and South America, Europe, Asia-Pacific region, Middle and Middle East, Africa). The objective nature and nature of disparities in the global economy. Asymmetries of global economic development and the forms of their manifestation (production-investment, scientific-technological, financial, social).

Topic 3. Civilizational dimensions of global economic processes.

Causes and factors of global economic processes. The civilizational component of global economic development. Classification of civilizational groups in the global economic space at the beginning of the XXI century. Trends in the economic dynamics of local civilizations.

The classic paradigm of countercyclical regulation of the economy and its effectiveness. Toolkit for countercyclical regulation of the global economy in conditions of synchronization of national business cycles.

Diversification of services and democratization of the terms of their provision in the global market. The latest types of services (outsourcing, outstaffing, consulting, coaching, etc.).

Peculiarities of the functioning of the global financial market and its impact on the world economic balance. Virtualization of financial flows and its dualistic nature.

Global strategies of transnational corporations and their modernization. Modern models of integration of national business structures into global transnational complexes. Problems of parity interaction of global business and states with different levels of socioeconomic development.

6. Training

The goal of the training in the discipline "Global Economy" is to form students a holistic vision, critical thinking and offer reasonable solutions based on the use of theoretical knowledge when solving practical tasks and the ability to meaningfully interpret the results obtained. Successful completion of the training contributes to the strengthening of the practical orientation in the training of specialists for the master's degree.

Tasks for training:

Choose the EU member state, the most significant industry and calculate:

- 1. industry concentration ratio by the number of employees,
- 2. the coefficient of diversification of production by the number of employees,
- 3. index of openness of the industry in relation to the world market,
- 4. the index of introduction of the industry into the world market,
- 5. the quota of imported final consumption goods in the total consumption of the country of one of the branches of the selected country.

The sectoral concentration coefficient based on the number of employees is calculated as follows:

$$ICR = \sum_{i=1}^{n} \left(\frac{L_i}{L} - \frac{M_i}{M} \right);$$

where

ICR – *industry concentration ratio*;

i – industry index;

n – number of branches of production by types of economic activity;

 L_i – number of employees in the industry i;

L – total employment in the country (for each i);

 M_{i} – the number of employees in the industry and in the metaregion;

M – total employment in the metaregion (for each i).

Accordingly, the coefficient of diversification of production by the number of employees has the following form:

$$IDR = \frac{1}{ICR} = \frac{1}{\sum_{i=1}^{n} \left(\frac{L_i}{L} - \frac{M_i}{M}\right)};$$

where

IDR – *industry diversification ratio.*

the diversification coefficient can acquire values within the limits. According to this scale, the closer the IDR value is to 1, the more evenly developed are the types of economic activity and production industries in the country. Conversely, the closer the value of the coefficient is to 0, the more monostructural the country's economy is.

The monostructural economy is characteristic of underdeveloped countries and regions of the world economy, and according to the level of economic development, monostructural countries and

regions can be at different stages of socio-economic development, which determines the specifics of production located in these countries and regions.

Thus, it is quite legitimate to distinguish diversified, weakly diversified and mono-industry structures by value.

In the context of identifying the degree of the country's participation in international production networks, it is important to determine the number of employees in the country's fields of specialization, auxiliary fields, and fields that serve production and the population. These values by groups of industries make it possible to find the value of the so-called multiplier of the country's specialization according to the level of employment (ML):

$$ML_{c} = \frac{M}{\sum_{s=1}^{n} L_{s}};$$

 ML_c – the employment multiplier of the country with the level of employment;

M – total employment in the metaregion (for all industries);

s – fields of specialization;

n – the number of branches of specialization by type of economic activity;

 L_{s} – the number of employees in the fields of specialization.

Level of Industry Exposure: Export Proportion of Total Trade – EPTT calculated as the ratio of the industry's exports to the total volume of foreign trade of the industry:

$$EPTT_i = \frac{Exp_i}{Exp_i + Imp_i}$$

where

 Exp_i – export of i - field;

 Imp_i – import of *i*-field.

Index $_{EPTT_i}$ is within the limits (0; 1), and if $_{EPTT_i} = 0$, then industry brunch i imports only, and if $_{EPTT_i} = 1$ – exports only.

Level of Industry Exposure: Export Proportion of GDP-EPGDP determined by the ratio of industrial brunch exports to the country's $i\ GDP$:
